

## Corrigendum to CPD Snapshot (February 2009)

### Approved standards cited in the Official Journal (not mentioned in the Snapshot)

1) The following standards are not included in the February version of the Snapshot as a consolidated amended version or a revision of the standard<sup>1</sup> has been published since the last publication of the list of harmonised standards under the CPD in the Official Journal.
